Faço saber que o Plenário Câmara Municipal de Teresina aprovou e, eu, sanciono a seguinte Lei:

Art. 1º Fica reconhecida a Cultura Evangélica como Patrimônio Cultural Imaterial do Município de Teresina, em razão de sua relevância histórica, social, cultural e comunitária para a formação da identidade local.

Art. 2º Para os fins desta Lei, considera-se Cultura Evangélica o conjunto de manifestações religiosas, culturais, sociais e comunitárias desenvolvidas pelas igrejas e comunidades evangélicas, incluindo, entre outras:


I – celebrações, cultos, encontros e eventos religiosos;

II – músicas, cânticos, corais, bandas e expressões artísticas de cunho evangélico;

III – ações sociais, educativas, solidárias e de promoção da cidadania;

IV – valores, tradições, costumes e práticas transmitidas entre gerações;

V – eventos públicos de caráter religioso e cultural realizados no Município.

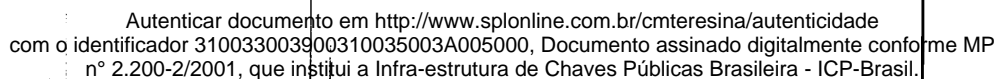

JUSTIFICATIVA


